Your Social Security number. If you have one.

Your driver's license number, if you have one.

Your alien registration number if you're not a U.S. citizen.

Records of investments, including stocks and bonds and real estate (not including the home you live in), and business and farm assets. If you have any.

A Federal Student Aid PIN to sign electronically. (You can get one at www.pin.ed.gov)

Bank statements, savings and checking account balances. If you have any.

Records of untaxed income, including child support, interest income and veterans non-education benefits. If you have any.

Federal tax, including W-2s. 2016

Registro de inversiones (Si tiene alguno), incluyendo acciones y bonos (no incluye la casa en la que vive) y negocios junto con bienes agrícolas.

Una clave Federal llamada PIN para firmar electrónicamente. (Puede obtener en www.pin.ed.gov.)

Cuentas bancarias (Si tiene alguna) balance de sus cuentas de ahorro y cheques

Récord de ingresos no agravados (Si tiene alguno) incluye pensión alimenticia, ingresos por intereses y beneficios no educativos de veteranos.
